INTRODUCTION

UK Gov guidance explains, 'due to a change in waste management law.......'

You need to separate paper and card from other dry recyclables (plastic, metal and glass), unless your waste collector collects them together and a written <u>co-collection agreement</u> is available. Waste collectors may also choose to collect other dry recyclable materials separately, like glass. You should discuss how your dry recyclable waste will be collected with your chosen waste collector.

You must always separate dry recyclable waste, food waste and black bin waste from each other.

Dry recyclable waste is:

- glass such as drinks bottles and rinsed empty food jars
- metal such as drinks cans and rinsed empty food tins, empty aerosols, aluminium foil, aluminium food trays and tubes
- plastic such as rinsed empty food containers and bottles
- paper and cardboard such as old newspapers, envelopes, delivery boxes and packaging

Food waste is:

- food leftovers (incl. left over buffet lunches, banana skins, apple cores)
- Coffee grounds and used tea bags
- waste generated by preparing food (of any volume, including if the workplace does not serve food or have a canteen)

Black bin waste or residual waste is:

- · absorbent hygiene products such as nappies
- highly contaminated materials like food packaging that cannot be washed

CONCLUSIONS AND DISCUSSION POINTS

You will need to discuss the waste disposal arrangements with your local provider.

You will probably need to provide separate bins for each waste type you need to separate unless provided by your waste disposal contractor or welfare provider.

These requirements apply to offices, yards and site welfare (including welfare vans).

For sites without waste arrangements, small amounts of segregated waste can be returned to the regional office or yard (as the company holds a Waste Carriers Licence).
