### SUBCONTRACT ORDERS & PAYMENTS

- Form 21 Subcontract Order has been updated to combine the previous Forms 21, 22, 23 and 21a and must be completed for ALL subcontracts.
  - NB all subcontract orders must be signed by a Contract or Commercial Manager or above.
- New Form 22 Subcontract Payment Certificate in Excel also incl Final Account & Pay Less Notice

### CONTRACT QUALITY DOCUMENTATION

- NEW Form 02 Works Information this replaces the old Job Instruction and introduces additional key information.
- Form 12 Quality Plan has been updated for clarity and now includes more key information.
- ITP and other QA templates are now available here: Quality Assurance
- <u>Process Documents</u> 02 Work Processing & Planning, 18 Performance Monitoring & Measurement, and 19 SHEQP have all been updated <u>Process 19</u> now includes clear guidance on the <u>minimum requirements</u> for contract quality planning documentation.

### **QUALITY & COMMERCIAL INSPECTION**
